SUBJECT: TRI-COUNTY TRANSPORTATION FOR SENIORS AND/OR

PERSONS WITH DISABILITIES MONTHLY PERFORMANCE

**REPORTS** 

#### RIDE CONNECTION

1. Overall ridership for E&D services for June 2017 decreased by less than 8% (-2,697) compared to June 2016. The reason is primarily related to funds that we had in FY16 that were specifically for medical trips. This equates to 2,232 rides of the decrease.

- 2. Total costs in June 2017 decreased by 22% (-\$164,939) for Ride Connection's E&D services. The largest decrease came from Providence Elder Place (PEP) (-\$81,493). This has to do with the fact that were fewer pay periods in June of 2017.
- 3. The network Cost Per Trip (CPT) decreased by 15%, to \$18.54 per trip compared to May 2016 (\$21.89). These types of anomalies occur when you look at a month's worth of data for comparison and are not significant in the larger context of rides performed and costs associated over a period of 12 months.

#### **RIDEWISE**

- 1. Service Delivery Analysis. A total of 164 persons were served through RideWise's one-on-one, classroom, group and trip planning by phone/mail training.
- 2. A total of 44 individuals successfully exited out of one-on-one travel training, 15 of whom were prior participants returned to learn a new route. Over June 2016 there was a 52% increase in the number of successful customers.
- 3. Under the age of 60, a total of 38 persons successfully exited out of one-one travel training, with an average of 8.9 hours of training.
- 4. Outreach. The RideWise program continues to increase awareness of the program by attending resource fairs, meeting with agency professionals,

mailings and presentations at staff meetings, etc. A total of five events was held:

- RideWise staff met with a representative from PHAME to discuss partnering on a new program video.
- RideWise staff met with SWEP coordinators to finalize details of travel training once students arrived in Portland.
- RideWise staff attended the Multnomah County Employment First meeting.
- RideWise staff presented to incoming students and parents at the Think College Inclusion orientation night at Portland State University.
- RideWise staff met with the staff at HireNW, new job developers in East Multnomah County.
- 5. Ride Ambassador Program. 106 volunteer hours were recorded for Rider's Club events, committee meetings and outreach.
- 6. Riders' Clubs. The RideWise program supported 10 Rider's Club activities with 94 participants.
- 7. Referral Sources. There were 57 referrals in June 2017. Seven referrals were from new agencies, or new sources at agencies, with whom a relationship had already been established. Seven referrals were the result of our travel options counseling efforts.
- 8. School Program. 238 students received training during the month of June. There were 1,533 trips taken as a group, 119 one-on-one trips and 99 teachers and support staff reported a total of 921 hours of training.

#### **SANDY AREA METRO (SAM)**

- 1. Total ridership this month was 11,276 an overall increase of 11%. This is the third month that Sandy Transit has been able to report a growth in ridership and is a good indication of the success of the new fare structure implemented in November 2016.
- 2. The SAM-Gresham route experienced an 11.9% increase in ridership. STAR ridership increased by 13.1%. The new Shopper Shuttle experienced a 13.8% growth over the previous month and a 71.7% increase over the first month of implementation.

- 3. The SAM Estacada route experienced a decrease of 25%; however, this is up from an initial drop of 45% due to route changes. The route experiences growth in ridership each month since those changes from last November. We expect this route to rebound entirely. The Elderly and Disabled program (out-of-town medical rides) experienced a 15.1% decrease, a welcomed slow to what has been a high demand service in recent years.
- 4. SAM partnered with Compassion Sandy in May. Compassion Sandy is a group of churches and volunteers who put together medical and dental services as well as clothing donations in a one-day event for low income families and individuals. SAM provided free rides to ensure there were no barriers for people to access the needed goods and services. Sam also partnered with Todos Juntos during the past few months to provide rides for families attending parenting classes at the local grade school. Three families were transported through the STAR program while one mother received rides through a non-profit known as Sandy Helping Hands, as her location was outside the SAM service area. SAM, Todos Juntos and Sandy Helping Hands worked together weekly to ensure each family was able to attend.
- 5. Sandy staff met with Arboc, ODOT, DAS and Creative Bus Sales to identify solutions for ongoing mechanical problems with two Arboc Spirit of Freedom buses bought in 2014 and 2016. Both vehicles continue to have problems and are not operational a significant percent of the time since being added to the Sandy fleet.
- 6. The Transit Assistant, Muna Rustam, attended a training at the Sandy Senior Center focused on meaningful interaction with people with Mental Health Issues. Staff also attended the quarterly Mt. Hood Transportation Alliance in May, at which it announced that the County has contracted with Sandy Transit for various administrative tasks for the Mt. Hood Express service. This was well received by the group. Sandy and County employees began meeting to exchange information, review documentation regarding a procedural policy and more for a smooth transition July 1, 2017.

### **SOUTH METRO AREA REGIONAL TRANSIT (SMART)**

1. SMART had a slight decrease in Out-of-Town Dial-A-Ride over June of last year with a 14% drop in overall ridership from last month. This drop in ridership was attributed to the climbing temperatures, making it more uncomfortable for riders to attempt first and last mile excursions. ADA

Paratransit was also down over last month by 28%. The following chart illustrates this month compared to the same time period last year.

- 2. SMART's new Grants and Programs Manager, Elli Work, started this month as did our Summer interns Justin Hanes and Bryce Yashikawa.
- 3. SMART's Transit Master Plan was officially adopted by the Wilsonville City Council on June 19, 2017.

#### **CANBY AREA TRANSIT (CAT)**

- 1. During the Month of June, overall CAT ridership was down 16.3%. Demand Response ridership was up 2.4% as compared to the same month in the previous year. It showed a data entry error in CAT's Paratransit LIFT and Cab statistics for the month of May 2016. The actual number of rides provided was 1,181 rides (not 11,811). This error impacted all year to date 12-month averages and percent of change numbers reported for May and June of 2017.
- 2. Ridership continues to slip. In addition to the reasons pointed to in previous reports (the implementation of a fare, TriMet service changes associated with the Orange Line opening, relocation of Albertina Kerr Center and CERP outside the Oregon City limits, the decreasing unemployment and low gas prices). There is a new cab company in Canby and there is also an increasing number of Uber and Lyft drivers available to Canby residents.
- 3. During this period, Jarrett Walker + Associates worked on the draft of the Transit Master Plan. If you would like to follow our progress check out the webpage.

### **SOUTH CLACKAMAS TRANSIT DISTRICT (SCTD)**

1. Ridership for the month of June dropped .07% over last year. At this time, it is unknown why ridership is dropping.

2. Office plans are complete. The District has requested proposals three times for bids to construct the building. The last bid was accepted by the Board. Construction is scheduled to begin in September.
