1. Call to Order

The meeting was called to order by Michael, with Tom Mills, TriMet's Service Planning Director, introducing the agenda and reminding attendees of the purpose of the meeting. Tom reviewed WebEx features and etiquette, particularly regarding muting, using reactions, raising hands, and the chat function. He also reiterated the importance of WebEx's recording, reminding attendees that all chat comments (including private messages) are logged.

2. Public Comment

Mary Lou opened public comments by addressing an \$11 million funding shortfall that impacts replacement vehicle procurement and service delivery for community-based transportation networks. She highlighted that the current fleet includes vehicles over ten years old, resulting in higher maintenance costs and unreliable service.

3. Timeline Update

Tom Mills provided an update on the STIF plan submission timeline, detailing the upcoming steps for FY26-27. The committee's next meeting in November will focus on voting to finalize the STIF plan. Following committee approval, the STIF plan will be presented to the TriMet Board on December 11 for final endorsement before the state deadline of January 16.

4. STIF Discretionary Grant Proposal Presentations

Transit Priority Spot Improvements, Lift Vehicle Replacement, Bus Stop Accessibility Improvements were presented with discussion points covering funding allocations and community impact.

5. FY26-27 STIF Plan Budget Review

Budget allocations and anticipated funding needs were discussed in detail. Major discussion points focused on Lift vehicle funding, subsidized fare programs, and anticipated regional coordination requirements.

6. Voting Preparation for November Meeting

The committee reviewed ODOT's dual questions regarding STIF applications: funding and ranking. Members unanimously agreed to recommend funding for all STIF applications without ranking.
