2:00pm Deaccession Recommendations

- Deaccession "Policy" Guidelines
 - Review outdated "policy," which is not official, but only a guideline; noting that Safety is TriMet's top criteria and artwork can be removed if it is deemed unsafe.
- Goose: Kings Hills/SW Salmon MAX Station
 - Committee members discussed and voted to deaccess the *Goose* sculpture and return it to the community.
- Table and Chairs: Park Rose Transit Center
 - The committee discussed if removing this piece would set precedent to further removal of other art pieces and if so, further funding would be needed to install other artwork at the site.
 - Committee members discussed and voted to deaccess the *Table and Chairs* sculpture and return it to the artist.

2:30pm Future Commissions

- Project briefing: Blue Line Station Rehabilitation Project NE 82nd Ave MAX Catherine Sherraden & Robert Vance
 - Provided overview of Blue Line Station Rehabilitation Project. The MAX Blue Line is the oldest line and precede the Public Art Program. The goal is to ensure safety, ease of maintenance and a more consistent look. This station may become a model to of how to plan for the next stations, which are E 148th and Hollywood/NE 42nd.
 - Reviewed plans for design changes at the station. Project is in design phase and will refurbish the current shelter and add a new shelter, replace concrete and guardrails, and add enclosed railings.
 - Planning to add a vertical sculpture on the center of platform, between the platforms. There is currently an existing mural at the site by Alex Chiu and new artwork will need to take this into consideration.
 - There will be a call for artists aka Request For Qualifications (RFQ); the draft RFQ will be emailed prior to next meeting for review.
